- Support audits of works and other assessments


Essential for making research outputs Open Access (and REF compliant)

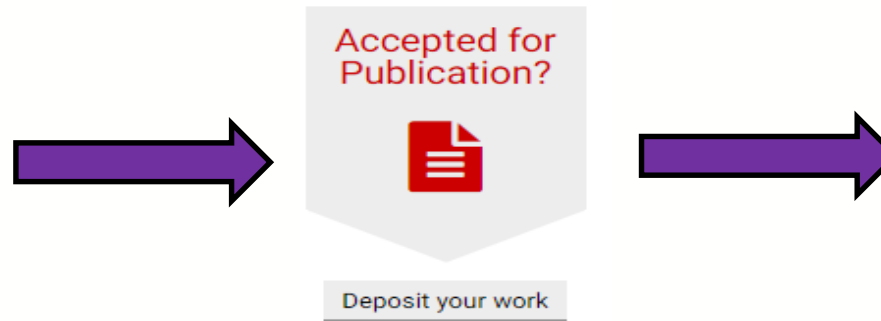



It's imperative your REF eligible outputs are compliant by uploading the correct file to Symplectic within 3 months of acceptance for publication.

# Open access and Impact

## Impact *inside* academia:

- Citation advantage
- Supporting, or driving forward, other areas of research

“Having a green [Open Access] copy of a paper is the **most impactful research communication strategy...**”

(Archambault, Côté, Struck & Voorons, 2016).

## Impact *outside* academia:

- Citizen science and public engagement
- Access to research for developing countries
- Wider debate and discussion

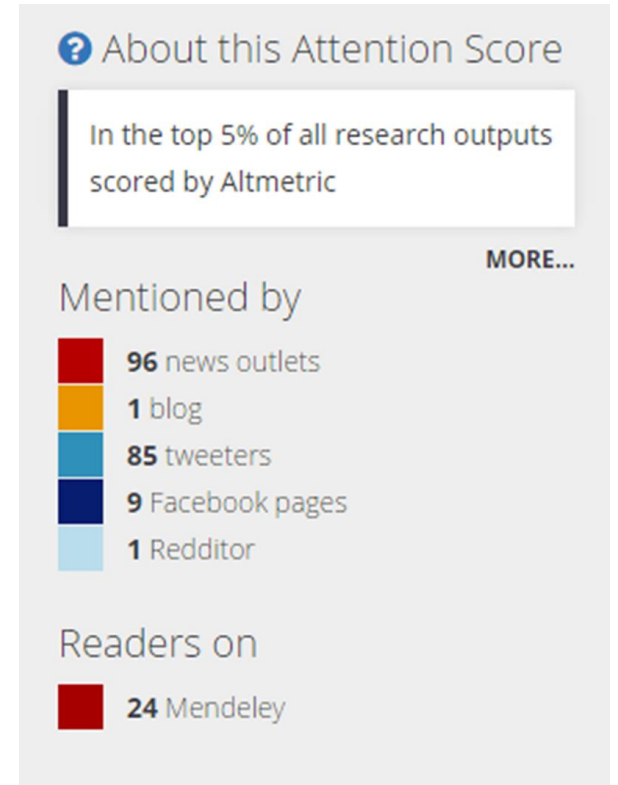
# Demonstrating Impact with Altmetrics
