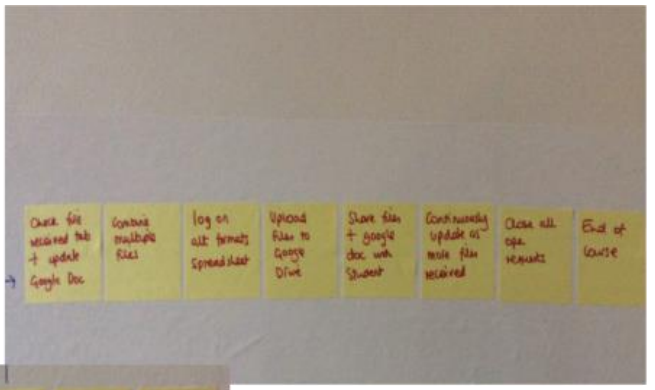
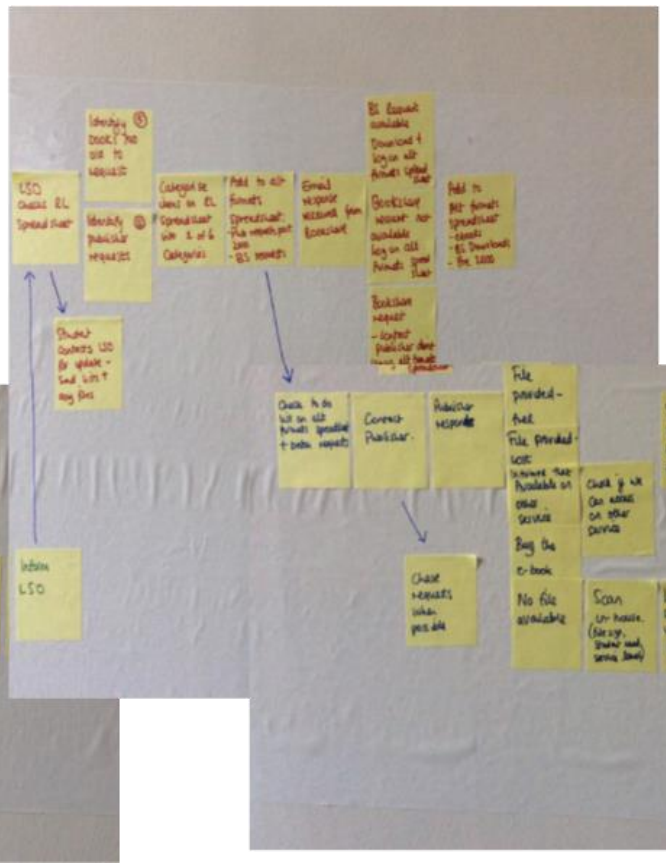
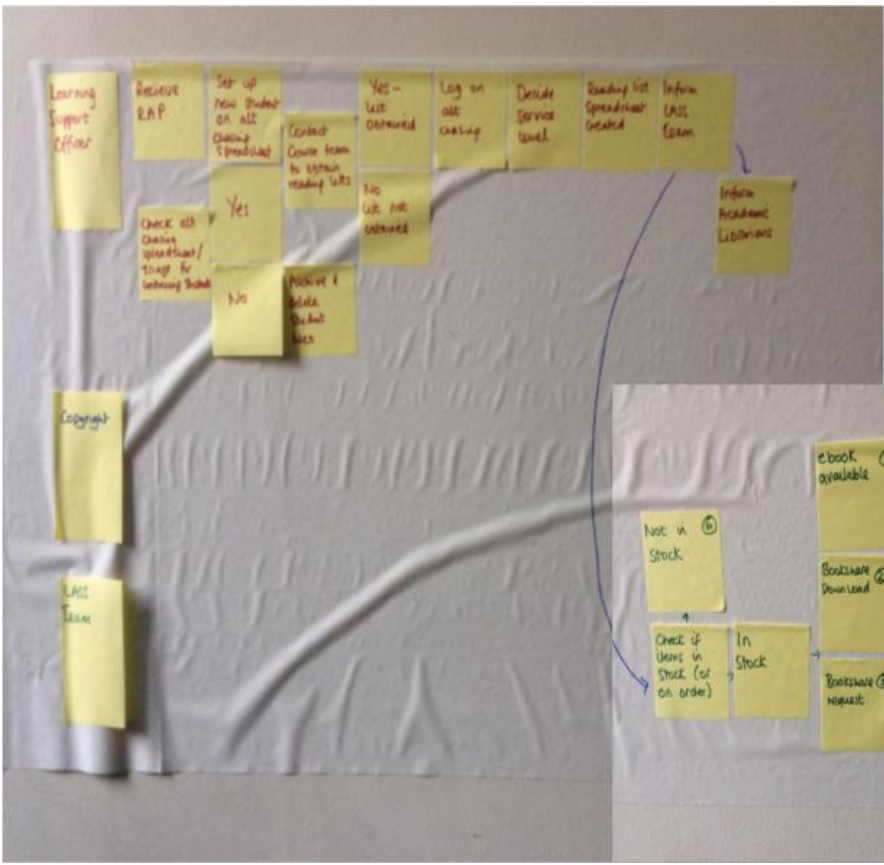

W. Edwards Deming







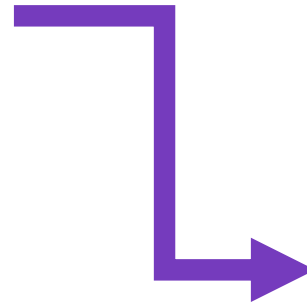
Waste identification

- Managing student expectations

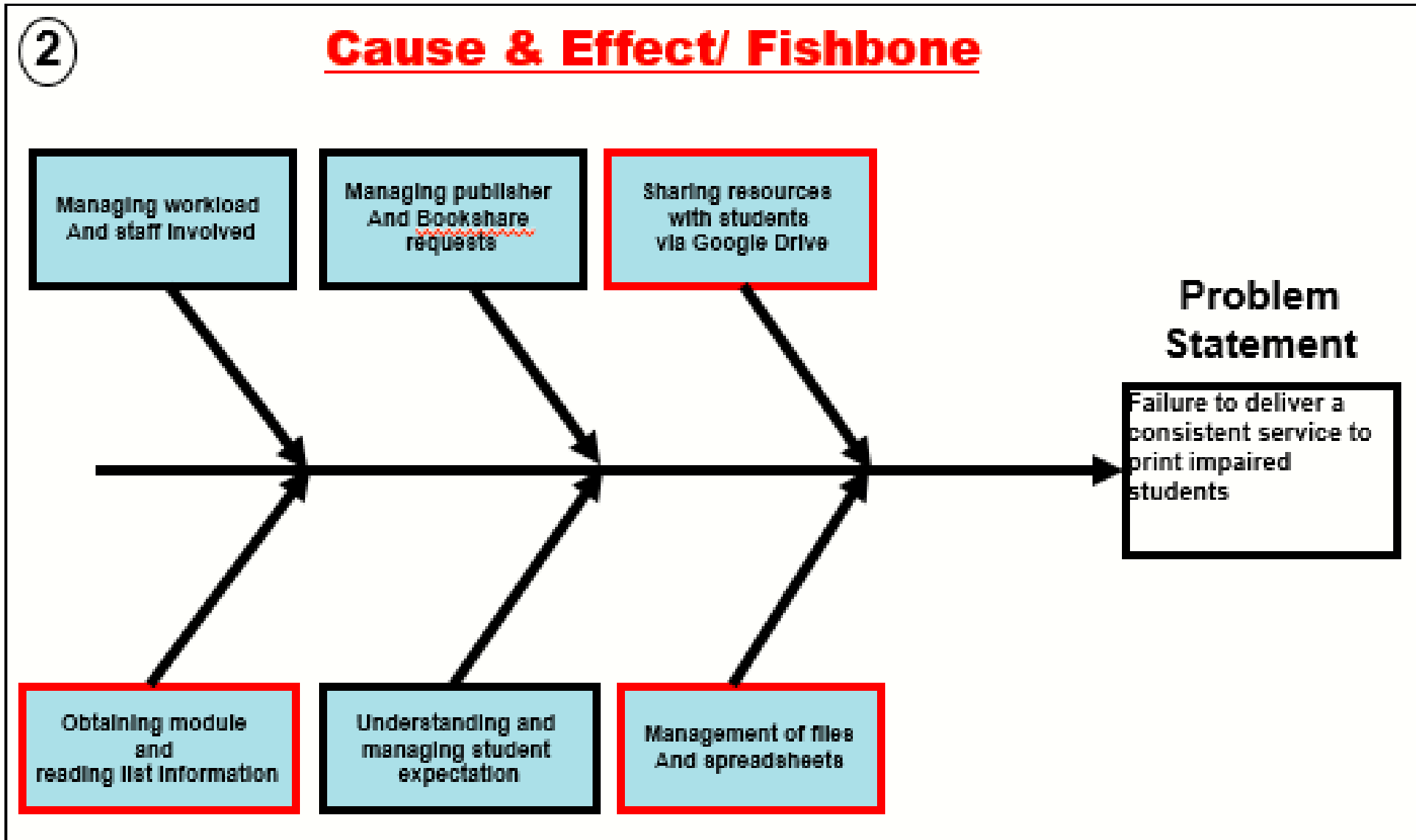


“Failure to deliver a consistent service to print impaired students”
